Progress on oversight

In 2023, oversight in our county made historic progress when the Board of Supervisors unanimously voted in favor of creating a new body to assist the Board in its duties relating to the Sheriff's Office. The Board has named this body the Independent Civilian Advisory Commission on the Sheriff's Office.

This new Commission brings us closer to, but does not fully implement, effective and independent oversight. The resolution creating the Commission lacks several essential elements, including a permanent Inspector General, as well as any mechanism for the Commission to

enforce compliance with requests for information. These elements are necessary to ensure robust oversight. There must be the capacity to respond to complaints, to request and receive access to data, to review policies, practices, trends and patterns, and importantly to have a professional Inspector General on an ongoing basis who can proactively identify and address issues before they lead to lawsuits or unwanted media coverage.

The Board voted to move forward by passing this resolution as a historic first step. Though the specific wording of the resolution does not meet all of the criteria for effectiveness, we do appreciate the Board treating the creation of oversight with urgency. Now that the Commission is set to begin meeting in mid-2024, Fixin' will monitor its effectiveness and continue to strongly advocate for areas where it needs to be strengthened.

Community Connections

Fixin' SMC continued its popular monthly webinar series through 2023. These events gave our supporters and the public the chance to hear from elected officials like Supervisors Corzo and Mueller, and Mayor James Coleman; experts on law enforcement oversight like Mike Gennaco and Jerry Threet; civil rights advocates like Alyssa Victory of the ACLU; and people impacted by and responding to law enforcement violence like Ekene Okobi.

We have had live Spanish interpretation at each webinar. Thank you to the Thrive Alliance for supporting interpretation at these events.

We were delighted to have our first coastside event in August 2023, at the Half Moon Bay Brewing Company. Speaking in support of our work were HMB's then Mayor Deborah Penrose, then Vice Mayor (now Mayor) Joaquin Jimenez, and City Council members Harvey Rarback and Debbie Ruddock. The celebration was co-sponsored by Abundant Grace, Puente de la Costa Sur, Coastside Families Taking Action, La Honda Indivisible, and The San Mateo County

Democratic Party Farmworker Affairs Committee. Our live auction raised more than \$2,500.

Our annual spring in person event in Belmont and our holiday party in Redwood City brought together supporters and elected officials including State Senator Josh Becker, Supervisor David Canepa, South San Francisco City Councilmember (now Mayor) James Coleman, Redwood City Councilmember (now Mayor) Lisette Espinoza-Garnica, Redwood City Councilmember Chris Sturken, Daly City Councilmember (now Mayor) Juslyn Manalo, and former San Mateo Mayor Rick Bonilla.

In March we launched the California
Coalition for Sheriff Oversight, together with
grassroots advocates in Alameda, Marin,
Monterey, Riverside, Sacramento, Santa
Cruz, and Sonoma counties, the ACLU
of Northern California, and the California
League of Women Voters Sheriff Oversight
working group. This provides a networking
opportunity and communication platform for
counties that are setting up oversight.

EACH QUARTER

Four times each year we host in-person events that bring together volunteers, supporters, and elected officials.









The Coalition for a Safer San Mateo County

In 2023 Fixin' San Mateo County helped create the Coalition for a Safer San Mateo County (CSSMC), made up of more than 30 local community organizations that support strong, independent civilian oversight of the Sheriff's Office. Faith groups, political and justice organizations, and civil rights advocates are represented. On September 12, 2023, the Coalition submitted the following letter to the San Mateo County Board of Supervisors.

Honorable President Pine, Vice President Slocum, and Supervisors Canepa, Corzo, and Mueller:

We, the undersigned, are sending you this letter on behalf of our below named community organizations. We represent organizations all over the county with an estimated 5,000 members among them, which are involved in civil rights, faith-based social justice, anti-racism, immigrant rights, and more.

We support the creation of an independent civilian oversight board and an Inspector General's Office with oversight of the County Sheriff's Office. Each of our organizations has officially voted to endorse oversight on behalf of its membership, including Fixin' San Mateo County, which helped bring our various groups together for this important cause. We join together in calling upon the County Board of Supervisors to pass a strong ordinance for civilian oversight as soon as possible.

Thank you for your leadership and support for oversight, allowing San Mateo County to be on the right side of history.

Moving forward in 2024


This year our goals are to continue to educate the public and Supervisors, make sure the new Commission is effective, and advocate to strengthen it as needed.
